New Business

- Vote New Board positions.
 - Franz motioned to except Darryn as president, Tanner seconded, motion passed John motioned to except Franz as vice president, Darryn seconded, motion passed Darryn motioned to except Bryce as Treasurer, John seconded, motion passed John motion to except Tanner as secretary, Bryce seconded and the motion passed.
- Tyson measured the cart path at 303' and 318'. Mericrete will give us a couple bids to install the new cart path on 9. The board will visit with Rick @ Great Life to see if he will help out with dirt and grass/sod.
- Roads: Todd Hurd will start the widening on Ottawa Ct soon and it will need to set a year before he finalizes the surface area. The Gonzlales home has a 22' x 40' gap between the road and their second driveway. They are asking to see who's responsible to fill that in with asphalt where its washed out. The board feels like everyone else in the past, it is the home owners responsibility.

- Darryn is planning on picking up the carp fish to put in pond 14, 16 and 18. The board approved \$600-\$700 last year to restock fish. Darryn also asked for \$270 to purchase dye to treat the ponds. Darryn motioned and Tanner seconded.. motion was approved
- Mark brought a bid to repair the flushing mechanism of the urinal downstairs. The board wants to get additional bids.
- PPL Loan: Bryce has checked on this. He feels that we probably do not qualify because of our tax exempt status.

- to cover expenses to replace the countertop behind the bar and construct a new cash register area. Tanner seconded and the motion passed.

- We still need bids on the guttering on the south side of building damaged by Great Life.

- Also Bryce thinks that we need a NO OUTLET or DEAD END sign on Lake Ridge Parkway because there is not a turnaround at the end and people keep going that way. Bryce will do some pricing.
